### 2014 ELECTIONS REPORT

Elections for the 2014 Lansing Jaycees Board of Directors are coming up soon! Elections will be held at the November General Membership Meeting (also known as the Annual Meeting) on Tuesday, Nov. 12, 2013, at 7 p.m. The GMM will be held at Tripper's (350 Frandor Ave., Lansing, MI). A social hour precedes the GMM if you'd like to arrive early.

Absentee ballots will be available and distributed to the membership. Members wishing to vote by proxy (designating someone else to vote for them) should contact the elections committee directly.

Only current members in good standing with the chapter are eligible to nominate members for a given position as well as vote in the election. All members interested in running for a board position must also be in good standing with the chapter. If there is any concern about a member's standing with the chapter, please ask the Elections Committee.

The Elections Committee members are Eric Richmond, Colleen Burton, Melissa Horste, and Beth Michaels.

#### **Procedures for Nominations**

Nominations for elected positions may be made and seconded verbally at the GMMs on Oct. 1 or Nov. 12. The nominated member must also be present and consent to being nominated. Nominations may also be made and seconded in writing to the Elections Committee at any time.

#### <u> Available Positions</u>

The following are positions and brief descriptions for which members in good standing may run. You may read more detailed descriptions in the chapter's Constitution and Bylaws, located in the file archive at <a href="https://www.lansingjaycees.org">www.lansingjaycees.org</a> or speak to current or past board members.

**President:** The president serves as the chief executive officer of the organization and has general charge of the business of the organization. The President presides at all meetings of the membership and of the Board of Directors.

**Secretary:** The secretary keeps the minutes of meetings of the membership and the board of directors.

#### **Available Positions** (cont.)

**Treasurer:** The treasurer keeps custody of the chapter's funds and provides accurate accounting of receipts and disbursements for the chapter. The treasurer ensures completion of tax returns and financial statements as required.

**Assistant Treasurer:** The assistant director assists and learns the duties of the Treasurer.

**Vice Presidents:** The vice presidents guide and support the following areas of opportunity: Management Development, Membership Development, Community Development, and Individual Development. They may also chair standing committees for these areas of opportunity.

**Directors:** The directors may assist a specific area of opportunity or serve as a director-at-large and assist the Board of Directors as requested.

The following positions are appointed by the president or elected by the Board of Directors:

**Legal Counsel:** Assess and provide recommendations to the Board of Directors as required or requested. The Legal Counsel must be an attorney.

**Chaplain:** Provide services to the membership and Board of Directors as required or requested.

**Parliamentarian:** The parliamentarian assists the presiding officers in questions of parliamentary procedure.


