## Hello again, Lansing Jaycees!

Well autumn is upon us again, and you can feel the magic of the season in the air. The wind is getting cooler, the leaves are changing, Spartans and Wolverines alike are taking to the grid iron, and the Lansing Jaycees are looking for their next round of leaders to serve on the board of directors (BOD or "the board").

Yes, it is elections time for the Lansing Jaycees, and before we can have elections we must have some nominations. Nominations began at our October General Membership Meeting (GMM), but they can continue until the time of elections at our Annual Meeting, which will take place at our November GMM on Nov. 11. I will discuss the nomination and election process more a little later.

Now, I have already been in contact with some of our members that are interested in serving on our BOD next year, but I thought it would be good to share with all of you some of the challenges and rewards of serving on the board.

That's right, I said challenges. I'm not going to lie, serving on the board is no cake walk, and it shouldn't be. After all, how can you expect to gain any reward from being on the board if the experience never challenges you? Being a member of the BOD will require a fair amount of your time and energy.

Aside from monthly meetings of the BOD, and attending the monthly GMM, many of your evenings and weekends will be at least partially dedicated to planning meetings and events. The specific expectations and requirements of attendance can vary somewhat from year to year, because it is up to each president to set the requirements. But, typically most board members are not required to attend every single event held by the chapter. It'd be pretty cool if you did, but I just don't think that's even possible. Generally, the rule has been in the past that you attend planning meetings for projects that are under your purview on the board. You would also be expected to attend the events that fall under your area of responsibility, when possible. When you can't make it, you'll need to make sure that another member of the board can be there so there is a board presence at the event.

As a member of the board you will also be present for all of the debate and discussion of the chapter's business. Sometimes the discussion will be simple and other times it will be contentious. You will, at times, disagree with your fellow board members and you will argue with them, or at least you better. Your role on the board is to represent the interests of our general members. If there is something happening that you don't like, you better believe there is at least one other person in our membership that agrees with you. And that means it is your responsibility to voice a contrary opinion when you have one. It can get heated at times, some people on the board will get upset with you when you stick to your guns, and you will get equally upset with them. At the end of it all, the BOD is a democracy, and there will be a vote to decide every issue. You will be emotionally invested in the plans of our chapter, and you will be upset when that vote doesn't go your way. The tough part is walking out of that board room confident that your fellow board members, your team, have voted and made the best decision for the chapter. But that is what you absolutely must do. The time for arguing a point is before the matter is settled by a vote. After that vote you have to leave the room knowing that your fellow board members are all competent human beings and that if they decide on a plan, you have to pour your support into that plan even if it wasn't the one you would have picked. You have to do this for the good of the chapter. Divided leadership is not going to help the members you agreed to serve. So, feel

free to voice your contrary opinion and argue in its defense as best you can while the matter is before the board. But once that issue is settled you must be prepared to swallow a little of your pride and go forth from that meeting in full support of the board's decision. I'm sorry if it seems I am going on about this point at too great a length, but this is possibly one of the biggest challenges you will face on the board. It can be very hard to put your support and effort into a plan you don't agree with, but you must be willing to do just that.

The main thing to keep in mind in all that you do as a member of the board is that you are there to further the interests of the chapter and its members. When you are considering your vote, you will need to consider not only your personal opinion, but whether or not this is good for the chapter. That must be the deciding factor in all of your votes. It cannot be about who or what you like and don't like. Most of the time, your interests and the chapter's will be one and the same, but you must be willing to put the chapter's best interests ahead of your own when they are not in sync.

Well, now that I've spent some time making board service sound like something nobody would ever be interested in, let me talk to you about the rewards. Believe it or not there are many rewards for serving on the BOD. But, because nobody gets paid to be on our BOD, they are mostly intangible rewards.

Perhaps most obviously you will be rewarded with an education in leadership. You will learn what it takes to properly delegate authority and responsibility, how to work effectively with people you don't see eye-to-eye with, and how to put the interests of the people you serve ahead of your own. This is a brief summary of exactly what I think a good leader should know, and serving on the BOD will help you with all of these.

The greatest reward for your service is one that some people may not recognize immediately. Your time serving on the BOD will give you many opportunities to gain some deep-seated friendships. You could get to know some of your fellow board members better than many of your long time friends. You will also get to know more of our general members, and find more people in our chapter that share your interests and sense of humor. I can say for a fact that I have made friends in the Lansing Jaycees that I will keep until the day I leave this planet. Friends that I would not hesitate to drop everything for if they needed help, and I know they'd do the same for me. Some of those friendships have come from my time as a general member, but many of them have come from my time spent serving on the board. That kind of reward is invaluable. To have an unwavering support network that will help you out when trouble arises, or laugh with you when trouble is far from anyone's mind, is rewarding on a level that is much deeper than any monetary gain. This is what people are talking about when they say money can't buy happiness.

So, these are things I'd like you to consider if you are thinking about serving on the BOD, either for 2015 or further in the future. ### **Notice of the Lansing Jaycees 2015 Elections**

Elections for the 2015 Lansing Jaycees Board of Directors are just around the corner. Nominations were accepted at the October, and may be made and seconded at the November GMM as long as the nominee consents to the nomination. Chaplain will be elected by the 2015 Board of Directors; interested parties should contact the 2015 president-elect.

#### **Available Positions**

The following are positions and brief descriptions for which members in good standing may run. You may read more detailed descriptions in the chapter's Constitution and Bylaws, located in the file archive at www. lansingjaycees.org or speak to current or past board members.

**President:** Serves as the chief executive officer of the organization and has general charge of the business of the organization. The president presides at all meetings of the membership and of the Board of Directors.

**Secretary:** Keeps the minutes of meetings of the membership and the board of directors.

**Treasurer:** The treasurer keeps custody of the chapter's funds and provides accurate accounting of receipts and disbursements for the chapter. The treasurer ensures completion of tax returns and financial statements as required.

**Assistant Treasurer:** Assists and learns the duties of the Treasurer.

**Vice Presidents:** Shall supervise the portfolios of the standing committees, shall chair the standing committees, and shall perform such other duties and have such other powers as necessary.

**Directors:** May assist a specific area of opportunity or serve as a director-at-large and assist the Board of Directors as requested.

**Legal Counsel:** Shall be a member in good standing of the Michigan Bar Association and represent the Lansing Jaycees in legal matters affecting the Corporation.

Also remember that we're collecting pop tabs for the Ronald McDonald House to go toward their fundraising efforts. Our goal is to collect 5 pounds for them!


## **Membership Report**
